QUALIFYING HEALTH CARE ORGANIZATION EXEMPTION LETTER
for Tumbleweed Center for Youth Development.
Effective: 01/01/2011 to 12/31/2011

Based on a review of the information you provided, the Arizona Department of Revenue grants this Exemption Letter to Tumbleweed Center for Youth Development for the period of 01/01/2011 to 12/31/2011. Tumbleweed Center for Youth Development is entitled to the Arizona Transaction Privilege and Use Tax exemptions for Qualifying Health Care Organization for the period of 01/01/2011 to 12/31/2011.

The Qualifying Health Care Exemption applies to Tumbleweed Center for Youth Development's qualified purchases or leases from the business classifications listed below. The exemption applies only to these eight business classifications. **The purchased or leased tangible personal property must be used by the organization solely to provide health and medical related educational and charitable services.** The Department does not issue exemption numbers. Please present a copy of this letter to your suppliers to show your Exempt status.

This exemption is subject to annual review to determine if any changes in your activity affect your exempt status. To qualify for exempt status after 12/31/2011, Tumbleweed Center for Youth Development must submit a written request to the Department at least 30 days before the first day of the next exemption period. Qualifying Health Care Organizations must include an annual financial audit performed by an independent CPA. (Please refer to Arizona Transaction Privilege Tax Procedure TPP 99-5 for further guidance.) **Please submit all correspondence and renewal requests to me at the address listed below.
